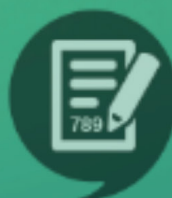

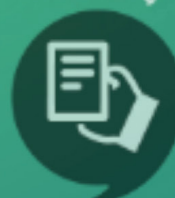

MVR 1.22 billion collected as the revenue of August

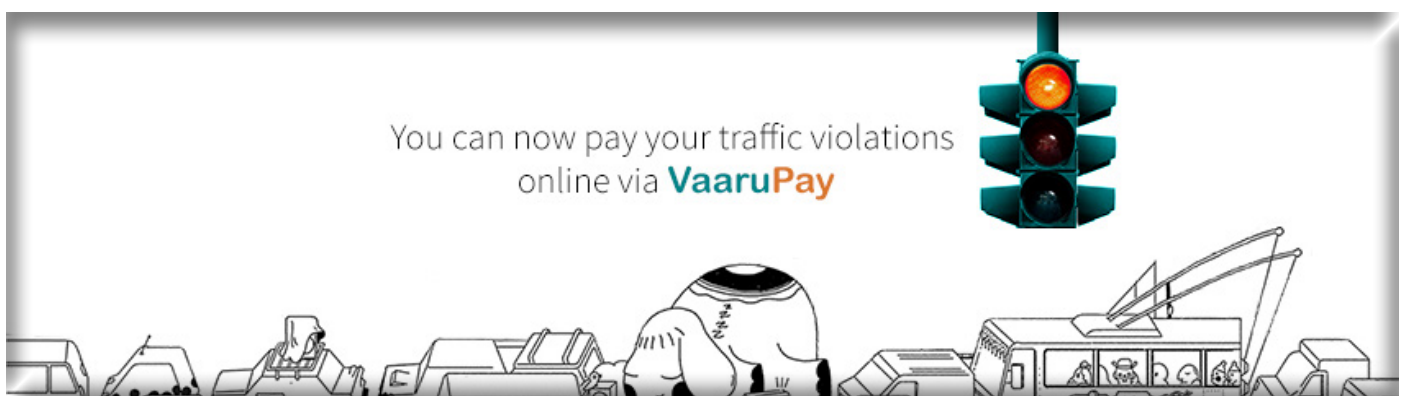
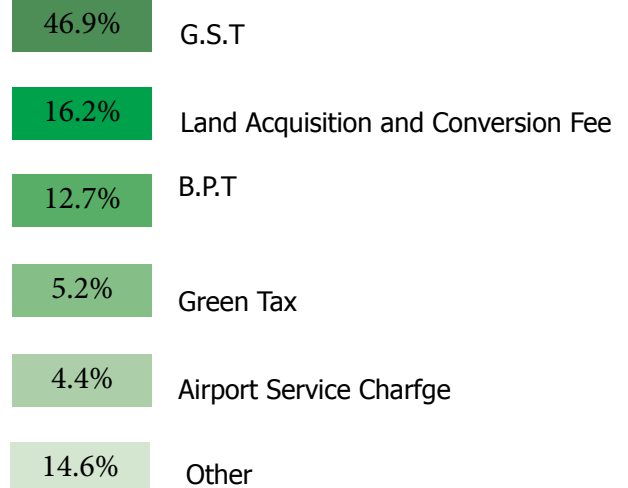
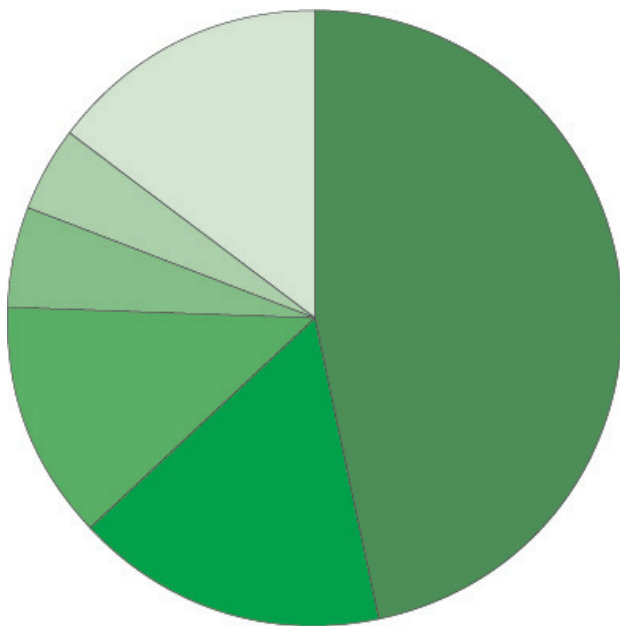

During August, MIRA collected MVR 1 billion. This is a decrease of 0.4% compared to the amount collected in August last year. This was mainly caused as a result of the changes brought to the due dates that were previously set to fall during the month of July.

The largest share of the revenue collected by MIRA during August was contributed by GST, amounting to a total of MVR 469.4 million and this accounted

for 46.9% of the total revenue. The second highest contribution was made by Land Acquisition and Conversion Fee (MVR 161.8 million) which accounted for 16.2% of the total revenue. In addition to this, a sum of MVR 126.9 million (12.7%), MVR 52.2 million (5.2%) and MVR 44.4 million (4.4%) was collected as BPT, Green Tax and Airport Service Charge, respectively, during the month.

August revenue collection also included 39.7 million of which 43.9% (USD 17.40 million) was solely derived from GST.

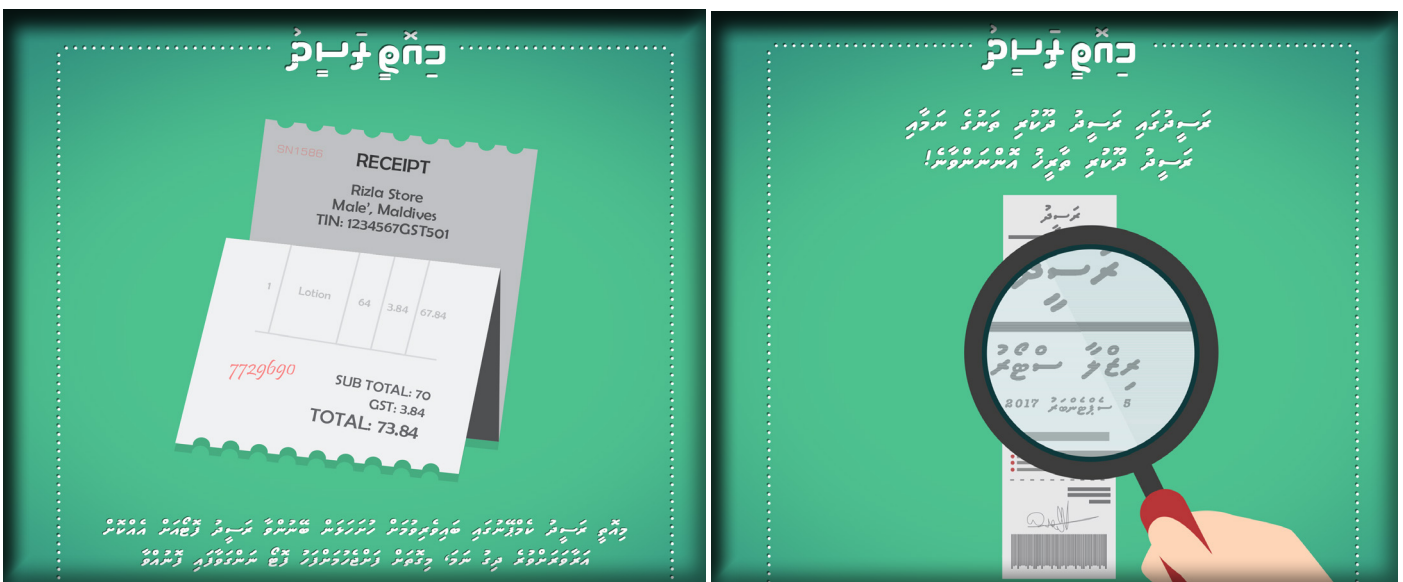
This campaign will be held from 5 September 2017 till 28 February 2018.
