Despite government offices being closed as a precautionary measure against the Covid-19 pandemic, as always, majority of the services provided by this Authority will be available online.

Our services will be provided online as follows.

Submission of Tax Returns

Taxpayers with MIRAconnect accounts can submit their tax returns and make payments online via MIRAconnect. Those who do not have a MIRAconnect account can register online for MIRAconnect.

Company Annual Fee, Vehicle Fee, Tourism Land Rent and Agricultural Land Rent can also be paid online via MIRAconnect.
