- If you wish to enter into an Advance Pricing Agreement (APA), submit this form to request for a pre-filing consultation. If you are submitting this form via email, email it to internationaltaxation@mira.gov.mv together with required documents.
- If you are a resident, you are eligible to request for an APA if you have entered or intend to enter into an international transaction in respect of which you are required to prepare and maintain transfer pricing documentation under Section 68(b) of the Income Tax Act.
- If you are a non-resident, you are eligible to request for an APA if you have a permanent establishment in the Maldives and have entered or intend to enter into an international transaction in respect of which you are required to prepare and maintain transfer pricing documentation under Section 68(b) of the Income Tax Act.
- Submit a letter of authorization in respect of the representative appointed in item no.7 of this form.
